## CHAPTER 641

### COUNTY JAILS

#### 641.01 CONSTRUCTION AND MAINTENANCE OF JAILS.

Where the county constructed a building for a jail and sheriff's residence and fitted up and used one cell-room as a jail, but, having no other county building, appropriated the remainder of the building for use as county offices, and installed several county officers therein, the sheriff cannot oust them. *Curtis v County of Lincoln*, 136 M 25, 161 NW 210.

The county commissioners may restrict the use that can be made of any portion of the jail not necessary for the use of the sheriff and his family for residence purposes; and if the remainder is rented out the revenue therefrom should go to the county treasurer. 1942 OAG 213, April 4, 1941 (390A-17).

Unless negligence is shown, the sheriff is not liable for money lost by a federal prisoner, though placed in a jail safe. OAG July 27, 1933.

The statute intends that a jailor shall be a deputy of the sheriff. The sheriff has the exclusive power of appointing a deputy to act as jailor, though such appointment is not effectual and complete until approved by the judge of the district court. Such jailor can be removed by the sheriff only. *State ex rel v McIntyre*, 25 M 383.
