No person during his lifetime, or corporation during its existence, could become the legal owner from a purchase sale from the state of more than 320 acres of land. 1912 OAG 561.

The section disqualifies a person owning 320 acres from purchasing more land for himself but is not applicable where such a person acts as agent for another, nor where he acquires additional state land by taking assignments of certificates of lands sold to others. 1912 OAG 561.

The statute is not retroactive in effect. 1912 OAG 561.
