

CHAPTER 362

BUSINESS RESEARCH AND DEVELOPMENT

NOTE: The department of Business Research and Development is established under the provisions of L. 1947, c. 587, and is under the supervision and control of a commissioner. It encompasses the following functions: (1) research and statistics, (2) publicity and promotion, and (3) enforcement; but the governor may assign new duties to the department, and transfer to it duties from other departments. The scope of the department is wide and there are no specific limitations. It may function in the way of research, statistics, publicity, promotion, and law enforcement in respect to all laws of a substantive nature having to do with business and the development thereof. The department is authorized to invoke the injunctive powers of the court without abridging the penalties provided by law. The funds, properties, appropriations, and personnel of the Minnesota Resources Commission and Minnesota Tourist Bureau were transferred to and the rights, powers, and duties of those agencies imposed upon the newly created department.
