POWER TO UNITE WITH MUNICIPALITY TO BUILD COURT HOUSE AND CITY HALL

COUNTY WITH CITY OF THE FIRST CLASS

**374.01 COUNTY AND CITY OF FIRST CLASS MAY BUILD COURT HOUSE.**

Ex. L. 1889, c. 64, creating a "court house and city hall commission" which has entire charge of the city hall and court house, with authority to contract for heating and lighting of the building; and may appoint a janitor, custodian, and such other employees as are needed for a period not extending beyond the year of the term of the members of the committee. The manner of appointment of members of the committee is approved. *Egan v City of St. Paul*, 57 M 1, 58 NW 267; *State ex rel v McCardy*, 62 M 509, 64 NW 1133; *State ex rel v Ermentraut*, 63 M 104, 65 NW 251.
