**350.01 AMOUNT.** Subdivision 1. **When paid.** The yearly salaries of the state officers and employees mentioned in this chapter shall be as herein fixed and all salaries shall be payable in semimonthly instalments.

Subd. 2. **Compensation for services.** All employees of the state shall receive compensation due them for services rendered semimonthly. This subdivision shall not apply to elective officers and heads of state departments who may be appointed thereto.

Subd. 3. **To be in full payment for services.** The salaries provided in this chapter for the officers and employees named herein shall be in full payment for all services that may be rendered by them either in the performance of their regular or special duties or while acting as a member or employee of any state board or commission.

Subd. 4. **Fees collected paid into state treasury.** All fees of any nature collected by any officer or employee named in this chapter shall be paid into the state treasury.

**350.02 GOVERNOR.** The yearly salaries to be paid to officers and employees in the office of the governor shall be as follows:

- (1) Governor, \$15,000;
- (2) Private secretary, \$8,500.

**350.03 SECRETARY OF STATE.** The yearly salaries to be paid to officers and employees in the office of the secretary of state shall be as follows:

- (1) Secretary of state, \$11,000; provided, that \$1,800 thereof shall be paid out of the sums appropriated annually for the salaries and expense of the motor vehicle division as salary of the secretary of state for supervising the division;
- (2) Assistant secretary of state, \$7,550.

## ADDENDA

### CHAPTER 763—S. F. No. 867

*An act relating to salaries and retirement compensation of judges of the district court; amending Minnesota Statutes 1949, Section 350.10, as amended by Laws 1951, Chapter 456.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 350.10, as amended by Laws 1951, Chapter 456, is amended to read:

350.10 The yearly salaries to be paid to the judges of the district court shall be \$11,700 each from the state and \$1,500 additional from each county in their respective districts having a population of 200,000 or more and \$300 additional in each judicial district having an area of more than 15,000 square miles from the counties comprising such judicial district in such proportion as the assessed valuation of each county bears to the total assessed valuation of such judicial district in the preceding year. When any district judge shall preside upon the trial or hearing of any cause outside of his resident judicial district wherein the district judge receives a larger salary he shall receive *as* additional compensation during the period of such trial or hearing the difference between his fixed compensation and the compensation of the district judge of the district where he has been so engaged, to be paid by the county wherein the trial or hearing was held upon certification of the senior resident district judge thereof.

The retirement compensation for judges of the district court who have heretofore *retired shall continue at the present rate of their retirement compensation and the retirement compensation of judges of the district court who shall hereafter retire shall be based upon salaries paid to such judges by the state* immediately prior to the passage of this act.

## SALARIES; STATE OFFICERS, EMPLOYEES 350.10

**350.06 ATTORNEY GENERAL.** The yearly salaries to be paid to officers and employees in the office of the attorney general shall be as follows:

(1) Attorney general, \$13,000;

(2) Deputy attorney general, \$10,500;

(3) Deputy attorney general, \$10,500;

(4) Six assistant attorneys general, each \$8,775; provided, that the salary of one of the deputy generals shall be paid from the funds of the State Highway Department.

**350.08 RAILROAD AND WAREHOUSE COMMISSION.** The yearly salaries to be paid the railroad and warehouse commissioners shall be \$9,000 each; \$1,500 of the annual salary of each commissioner shall be paid out of the appropriation for the grain inspection division.

**350.09 SUPREME COURT JUSTICES.** The yearly salaries to be paid to the chief justice and associate justices of the supreme court shall be as follows:

**350.091 CLERK AND DEPUTY CLERK OF SUPREME COURT.** The yearly salaries to be paid to the clerk and the deputy clerk of the supreme court shall be:

(1) Clerk of the supreme court, \$7,200;

(2) Deputy clerk of the supreme court, \$5,400.

**350.092 SUPREME COURT EMPLOYEES.** Within the limits of the appropriations for the salaries thereof and subject to the conditions of such appropriations, the supreme court may employ a supreme court reporter, a marshal, and such additional technical, clerical, stenographic, and other personnel as is necessary.

**350.10 DISTRICT COURT JUDGES.** The yearly salaries to be paid to the judges of the district court shall be \$10,200 each from the state and \$1,500 additional from each county in their respective districts having a population of 75,000 or more and \$300 additional in each judicial district having an area of more than 15,000 square miles from the counties comprising such judicial district in such proportion as the assessed valuation of each county bears to the total assessed valuation of such judicial district in the preceding year; provided, that when any district judge shall preside upon the trial or hearing of any cause outside of his resident judicial district, wherein the district judge receives a larger salary, he shall receive an additional compensation during the period of such trial or hearing the difference between his fixed compensation and the compensation of the district judge of the district where he has been so engaged, the same to be paid by the county wherein the trial or hearing was held upon certification of the senior resident district judge thereof.

The retirement compensation for judges of the district court now in effect for such judges who have heretofore or shall hereafter retire shall not be increased by reason of the change in salaries provided for in this section, but shall be governed by the provisions of law and based upon salaries in force immediately prior to April 18, 1951.

**350.11 MILEAGE, ALLOWANCE; EXCEPTION.** The maximum amount which shall be paid by the state, any department or bureau thereof, or any county, city, village, town, or school district, to any officer or employee, except sheriffs or deputy sheriffs, as compensation or reimbursement for the use by such officer of his own automobile in the performance of his duties shall not exceed seven and one half cents per mile, provided that in counties having a population of 550,000 inhabitants or over when the county board shall determine that because of low mileage operation of his car and the cost of parking fees and incidental expenses the rate per mile is not adequate to reimburse any such officer or employee, it may make him an allowance in lieu of mileage not to exceed \$20 per month; and provided further that in cities of the second class operating pursuant to the provisions of a legislative charter the city council thereof, or other appropriate governing body, may pay an allowance in lieu of mileage to employees other than elected city officials, which said allowance in lieu of mileage shall not exceed \$40 per month.

This section shall be construed as amending all existing laws authorizing such allowances or reimbursements by imposing the maximum limit above set forth.
