350.083 OTHER OFFICERS AND EMPLOYEES IN UNCLASSIFIED SERVICE. The salaries of all other officers and employees in the unclassified service in the executive branch of the state government whose salaries are not specifically fixed by sections 350.011 to 350.087 or any other provision of law shall be adjusted to the class of persons in the classified service, performing comparable work and having comparable responsibility, as determined by the director of civil service, but in no event in an amount in excess of the maximum of such class.

350.084 GOVERNOR MAY FIX CERTAIN SALARIES. The salary of a department head and any deputy of a department head occupying a position in the unclassified service hereafter established whose salary is not specifically prescribed by law shall be fixed by the governor in an amount comparable to the salary of a department head or a deputy of a department head having similar duties and having responsibilities as prescribed by sections 350.011 to 350.087.

350.10 DISTRICT COURT JUDGES. The yearly salaries to be paid to the judges of the district court shall be \$14,500 each from the state and \$1,500 additional from each county in their respective districts having a population of 200,000 or more. When any district judge shall preside upon the trial or hearing of any cause outside of his resident district wherein the district judge receives a larger salary he shall receive an additional compensation during the period of such trial or hearing the difference between his fixed compensation and the compensation of the district judge of the district where he has been so engaged, to be paid by the county wherein the trial or hearing was held upon certification of the senior resident district judge thereof.

350.11 MILEAGE ALLOWANCES. Subdivision 1. The maximum amount which shall be paid by the state, any department or bureau thereof, or any county, city, village, town, or school district, to any officer or employee, except sheriffs or deputy sheriffs, as compensation or reimbursement for the use by such officer of his own automobile in the performance of his duties shall not exceed seven and one-half cents per mile.

Subd. 2. In counties having more than 300,000 and less than 450,000 inhabitants, and in any city of the first class situated in such county, the county board or the welfare board supported jointly by such county and a city of the first class therein, or the governing body of such city of the first class, may determine to pay, and in counties having more than 550,000 inhabitants, the county board may determine that the county shall pay a base allowance of \$1.50 per day for each day the employee or officer's automobile is officially used. This base allowance shall not be paid for more than 20 days in each month. The minimum base allowance shall be \$20 per month for each employee or officer required to have his own automobile available for official public business and using that automobile for such business periodically throughout the month. If a base allowance is paid it shall be in addition to a mileage allowance which shall not exceed seven and one-half cents a mile for the first 500 miles in any one month and five cents a mile thereafter.

Subd. 3. In cities of the second class operating pursuant to the provisions of a legislative charter the city council thereof, or other appropriate governing body, may pay an allowance in lieu of mileage to employees other than elected city officials, which said allowance in lieu of mileage shall not exceed \$40 per month.

This section shall be construed as amending all existing laws authorizing such allowances or reimbursements by imposing the maximum limit above set forth.
