vestment in accordance with section 11.17. Residents' moneys on deposit in this account may be placed in this account only after the member has signed an agreement that he is willing to have the money in an account that does not draw interest directly to the resident himself.

There is annually appropriated from the account established by this section a sufficient amount to return to the Minnesota veterans home, upon written request, sufficient money to satisfy the demand of residents for the return of their money and other requirements.

The interest earned from the investment of the deposits is annually appropriated to the commissioner from the account established by this section to be used by the commissioner only for the direct benefit of the residents of the home, and the interest shall be available to the home not less than twice each

#### 201.021 Permanent registration system.

A permanent system of voter registration by county is established. Any county containing no city with a population of 10,000 or more may by resolution of the county board be exempted from the provisions of sections 201.021 to 201,221. The county auditor shall be chief registrar of voters and the chief custodian of the official registration records in each county.
