198.31 Veterans home, Hastings.

Control of the state hospital facilities at Hastings is transferred to the commissioner of veterans affairs. This transfer includes the cemetery. The commissioner shall establish a 200 bed veterans home in these facilities. The veterans home shall be licensed in accordance with the boarding care rules of the department of health. To the extent practical, the veterans home at Hastings shall be operated in the same manner as provided for the Minnesota veterans home at Minneapolis by sections 198.001 to 198.265.

CHAPTER 201. REGISTRATION OF VOTERS

201.15 Probate judge, report guardianships and commitments.

The judge of probate in each county in the state shall report monthly to the county auditor the name, age and address of each individual 18 years of age or over residing in the county who, during the month preceding the date of the report, was placed under a guardianship of the person or adjudged legally incompetent by reason of mental illness, mental deficiency, or inebriation, or as a psychopathic personality, and each such individual transferred to the jurisdiction of or restored to capacity by the court, or transferred from guardianship to conservatorship. Upon receipt of the report, the auditor shall examine the original and duplicate registration files to determine if any individual named in the report is registered to vote. The auditor shall attach a notice to the original and duplicate registration cards of any individual so named informing the election judges that the individual is not eligible to reregister or vote. The notice shall contain the reason for ineligibility, the date of the determination, and the dated signature of the county auditor. Upon notice from the judge of probate of a restoration to capacity, or of a transfer from guardianship to conservatorship, the county auditor shall remove the notice from the individual's registration cards and thereafter process the cards in the same manner as if no guardianship or adjudication had occurred.

203A.13 Ballot, designation.

On the back of all ballots shall be printed the words, "Official Ballot," the date of the election and lines for the initials of two judges. The printing shall be so placed as to be visible when the ballot is properly folded for deposit.

203A.15 Substitute ballots.

If the ballots are not delivered, or are stolen or destroyed and sufficient regular ballots cannot be seasonably had, the county auditor or other proper official shall cause other ballots to be immediately prepared as nearly in the form prescribed as practicable, with the word, "Substitute" printed in brackets immediately over the word "Official Ballot," as endorsed on regular ballots, accompanied by his initialed affidavit that the same have been so prepared and furnished by him, and that the original ballots have not been received, or have been destroyed or stolen, as the case may be. The judges shall cause the substituted ballots to be used at the election.
